SBHC Expansion in Oakland

- Seven original health centers in Oakland, developed between 1989 and 2005
- In 2006, Oakland voters passed Measure B, which allocated \$435 Million in facilities bond dollars to be administered by OUSD for school modernization projects
 - Allocated funding for construction of 10 school-based health centers facilities, including 8 new health centers and 2 renovations

Benefits of FQHC Model

- Strong network of FQHCs in Oakland, committed to providing school health services
- Capacity to provide range of services, including medical, mental health, health education, youth development services (5 sites also provide dental treatment on-site)
- FQHCs are the primary care provider for many of our families
- FQHCs conduct third party billing to sustain health center services - 25-35% of overall operating budget
- Leveraged funding model extension of Alameda County model to provide access to the uninsured (indigent care)



Benefits of Integrating School Nursing into SBHC Model

- Responsibility of School District to Meet Mandated Services
 - Screenings
 - Special Education/IEPs
 - 504 Plans
 - Management of Chronic Conditions/administration of medications
 - SST meetings/COST meeting
- Population Health vs. Individual Health Model
- Case Identification/Case Management
- Management of Communicable Diseases
- Documentation in AERIES District Database
- Support sustainability of SBHCs
 - Increased Referrals
 - Maximizes ability for partner agencies to focus on reimbursable services

Layered Funding to Support School Nursing at SBHC Sites

- General Purpose Funds
- Philanthropy (Kaiser)
- Programs for Exceptional Children
 - .1 to .4 FTE per site, depending on Special Education caseload
- LEA Medi-Cal Billing
- Site-based funding leveraged to increase FTE dedicated to school site


