


Tooth Decay Prevalence (%) in 3rd Grade Children


Percentage of students with Caries Experience (treated or untreated tooth decay)





In California...

- More than 60% of students have experienced tooth decay by third grade.*
- 1 in 5 kids have untreated tooth decay.*
- Approximately 440,000
 children missed at least one day of school due to a dental problem in 2018.**



Important Facts About Oral Health and Children

- ▶ 40% of kindergarteners have tooth decay
- 440,000 missed days
- \$85/day = \$37.4M loss revenue for schools
- Oral health is the leading cause of school absences (1)
- Students with tooth pain in last 6 months were 4x more likely to have low grade point average (2)





Important Facts About Oral Health and Children (cont.)

- ▶ Healthy teeth are important for overall health.
- School based programs help prevent dental decay.
- Decrease dental decay and pain = decrease absenteeism.
- ► We ALL can be an advocate for oral health education and services for school age children.
- Caries disease is 100% preventable.

School Dental Program Models

#1 School Screening

- School-linked
- Case identification and referral management

(e.g., hearing & vision screening → KOHA)



#2 Sealant Program

- School-based
- One time contact for a long lasting clinical preventive service

(e.g., Immunization → Tooth Sealant)



#3 Comprehensive dental care in schools (primary care)

- School-based
- Ongoing care: dental cleaning, x-rays, exams, fillings, etc.
- Refer to local dental office

(e.g., Mobile dental van, Virtual Dental Home)



Supporting Kids in Their Oral Health: School Dental Programs

- ► Train nurses in oral health prevention
- ▶ Implement oral health education in classroom curriculum
- Start a school-linked program (e.g., screening, support KOHA)
- Consider a school-based program (e.g., sealant program)
- ▶ Refer kids → comprehensive care → local dental offices or Virtual Dental Home
- ► And...



Partner with Local Oral Health Programs (LOHP)

- ► Prop 56 Tobacco Tax, 5-year grant cycle
- ▶ 59 of 61 local health jurisdiction (LHJ) has LOHPs in the current grant cycle July 2017 – June 2022
- New grant cycle July 2022 − June 2027
- School-linked or school-based grant objective



How to Identify Schools for Dental Programs

Definition for targeting a school for school-linked or school-based dental programs:

- ► All public elementary urban schools with > 50% of students on the free/reduced meal program (FRMP).
- All rural schools are considered eligible

State Oral Health Plan and LOHP Goals

- ► VISION = Eliminate oral health disparities
- ► GOAL = 10%
- ▶ Decrease tooth decay and untreated tooth decay by 10% points
- Increase sealant prevalence by 10% points
- ► At least 50% of eligible schools with a dental program by 2027



Tuolumne County: Superintendent of Schools & Smile Keepers Dental Program

- County Office of Education
- ▶ 1995, preventive dental services to Tuolumne county schools, 4 local schools
- Mobile dental van: screenings, dental cleanings, sealants, fluoride varnish
- Referral to local dental offices
- ► 4750 students



The L.A. Trust & LAUSD Oral Health Initiative

 A comprehensive public health approach to meet the oral health needs of LAUSD students

 Standardized oral health education, prevention and early intervention program across LAUSD since 2012, including:

Universal education for teachers, students, and parents

Universal screening and fluoride varnish

Special emphasis in kindergarten students

- Establishing dental hubs throughout the district
- Case management and referral processes
- Oral health policy advocacy
- Oral health data collection



Implications for School Performance

A 2012 study of oral health needs in LAUSD found that students with toothaches are almost 4 X more likely to have a low-grade point average.

1 in 3 school absences was dental-related which amounts to, on average, 2.2 missed school days each year due to untreated dental disease.

588,696 students

Children's Oral Health Status

Children & School Performance



73% of underserved children in Los Angeles have untreated caries.



Students with toothaches are almost **4 times** more likely to have **low GPAs**.



81% of underserved children in Los Angeles needed dental care.



Students without access to needed dental care were almost **3 times more likely to miss school** than students with access.



Oral Health Ed Online during COVID lock down

Three oral health videos aired on LAUSD District's TV channel, KLCS

 One-minute spots aired over 150 times and were viewed more than 1.1 million times

 Videos have been shared with 18 Early Education Centers (EECs) and all Local District (LD) South Elementary Schools



Ord Health Toolkit

The multimedia <u>Oral Health Toolkit</u> featuring links to kids' oral health videos, local dental services referrals, state oral health assistance programs and more

Addresses barriers to oral health access that was experienced by many students during the pandemic by informing the community on why, how and where to get care







South Central Family Health Center

- Federally Qualified Health Center (FQHC)
- Serving community of South Central Los Angeles for over 40 years
- Comprehensive Health Center
 - Medical
 - Dental
 - Behavioral Health
 - Optometry



South Central Family Health Center (SCFHC)

- 10 Medical Clinic sites
- 3 Dental clinics
- 2 School Based Wellness Centers
- Vision care clinic
- Pharmacy
- Mobile Van Unit



Patient Population


- Low-income population
- Continually changing demographic population
- Predominately Hispanic (90%), 10% mix of other ethnicities
- Transient
- Densely populated area ~100,000 people in one square mile
- Access to medical and dental care a significant need in community

Need for Dental Services in South LA

- Centers for Medicare and Medicaid Services recommends ratio of one provider for every 1,500 patients
- California Office of Statewide Health Planning and Development defines a geographic area:
 - Unusually high needs if the ratio of 1 provider exceeds over 4,000 patients
- In South Central LA, most dental providers are community health centers or dental schools

Dental Desert

- South Central LA: less than one dental provider per 10,000 people
- Insufficient dental services, high population density, low median household income
- <138% of Federal Poverty Level
 (FPL) = Medi-Cal eligible
- South Central LA: 80% patients qualify for Medi-Cal



History of Dental and Wellness Center

- Dental Services Started in 2013
- HRSA grant for creation of School Based Wellness Center at Jefferson High School for Medical Services
- Partnership with LAUSD to provide oral health education and access of health services for students
- Added Dental Services due to overwhelming patient need for oral health services
- Purpose of Wellness Center to provide medical and dental home for LAUSD students and families

Jefferson Wellness Center

- Dental: 2 Chair clinic
- Medical: 4 Exam Rooms
- Comprehensive dental services provided
- Medical: Sports physicals, vaccinations, confidential services
- Behavioral Health: Counseling
- Clinic evolved into community health center for surrounding population
 - 25% patients are LAUSD students and families



Goals for the Wellness Center

- Integration of Medical, Dental, and Mental Health Services for students and community
- Increased health awareness for LAUSD students
- Additional resource for Healthy Start counselors and School Nurse
- Educational Fairs and Oral Health Screenings for Jefferson High School and feeder primary schools with LA Trust

How to set up Dental Clinic

- Dental Chairs
- Vacuum/Compressor System
- X-ray Unit
- Water/Electric Lines
- Patient and Staff Safety First
- Infection Control Protocol



Daily Challenges

- Active Consent for Dental Services in LAUSD
- Not a problem for Medical and Mental Health (Confidential) services
- Education for students and families about benefits of Medi-Cal programs
- High No-show and broken appointment rates
- Compliance with oral health recommendations and treatment plan completions

Dental in the Time of COVID Pandemic

- Pandemic in March 2020
- Possible correlation between Dental and COVID-19 transmission (CDC, LADPH)
- Limited Dental Services
- Increased PPE guidelines and infection control protocols



Dental in the Time of COVID Pandemic





Resumption of Dental Services

- May 2020: LADPH and CDC recommended limited Aerosol-Generating Procedures (AGPs) and increased PPE guidelines (N95 masks)
- June 2020: Re-opening of SCFHC dental clinics
- July 2020: AGPs done with negative COVID-19 test for patients, HEPA filters installed
- January 2021: Resume all dental services previously restricted
- February-April 2021: SCFHC employees vaccinated for COVID-19

Bridging Medical and Dental

- Continue to develop integrations between medical, dental and behavioral health programs
- Pediatric patients: same day well child and oral health visits
- Chronic diseases patients: diabetics
- Women's health patients: oral health and prenatal care
- New bridge in process: Mental health and oral health
 - SBIRTs program- substance abuse intervention and mental health (depression and anxiety) have effect on maintenance of oral health

Community Health Partners

- LAUSD: Wellness Center
- LA Trust: Oral Health Screening Events and Tooth Fairy Festivals
- UCLA School of Dentistry: endodontics, oral surgery, and pediatric specialist programs



Future for Jefferson Wellness Center

- Mobile Van Unit for Oral health screening events
- COVID-19 vaccinations and testing
- New health center in heart of Jefferson HS campus in 2024 (LAUSD modernization grant)
